What is the OEP?



Our mission

Our mission is to protect and improve the environment by holding government and other public authorities to account.

The Environment Act 2021 established the Office for Environmental Protection (OEP) as a **new public body**.

Our principal objective in exercising our functions is to contribute to environmental protection and the improvement of the natural environment

Our remit covers **England, Northern Ireland** and **reserved matters**

Funded by, but **independent of Defra and Daera**

Counterpart of **ESS and IEPAW**

Part of the **new system of environmental governance** in the Environment Act

We have just had our 2nd birthday in England, powers in Northern Ireland came into effect in March 2021

Our remit – Environment Act 2021



s.28 – Monitoring and reporting on environmental improvement plans and targets.

s.29 – Monitoring and reporting on environmental law.

- Review and report on government's progress in meeting environmental goals and targets
- Monitor and report on the implementation of environmental law
- Advise government on proposed changes to the law and other environmental matters
- Investigate suspected failures to comply with environmental law by government and other public bodies and enforce compliance where needed

The public can make a complaint to us where they suspect that the government or a public authority has failed to comply with environmental law.

Our remit – who we hold to account



The organisations and individuals we can hold to account include:


- government departments
- government ministers
- regulators
- local authorities
- some private bodies, such as water companies – but only in respect of their public powers and duties

Duty to co-operate

Public authorities have a duty to cooperate with the OEP and give it such reasonable assistance as it requests including the provision of information

Our remit - engagement

- We **work with public authorities in different ways**, as we undertake our different functions.
- We **engage, listen, and learn from stakeholders**, drawing on and respecting the deep technical expertise of specialist bodies, including those in government.
- We seek to earn the trust and respect of all organisations we work with through being **independent, objective, impartial and reliable**.



Four Main Functions

The Environment Act sets out our powers and duties:



Scrutinising Environmental Improvement Plans (EIPs) and targets

We review and report on progress in delivering environmental improvement plans, goals, and targets.



Scrutinising environmental law

We monitor and report on the implementation of environmental law.



Advice

We advise government on proposed changes to environmental law and other matters related to the natural environment.



Enforcement

We investigate suspected serious failures to comply with environmental law by public authorities and enforce compliance where needed.

Four Main Functions



Scrutinising Environmental Improvement Plans (EIPs) and targets

We review and report on progress in delivering environmental improvement plans, goals, and targets.

Government is held to account for delivery of environmental goals and targets, and its plans for environmental improvement.

Monitoring the EIPs and targets

- The OEP has a duty to monitor governments' progress with their EIPs
- Our reports are laid before Parliament/ NI Assembly and the government must respond
- We published our first statutory report on the England EIP in Jan 2023
- The Northern Ireland assembly has yet to publish its EIP



Four Main Functions



Scrutinising environmental law

We monitor
and report on the

The environment is protected and improved, and people are protected from the effects of human activity on the natural environment, through better design and implementation of environmental laws.

Monitoring the implementation of environmental law

- The OEP has a duty to monitor the implementation of environmental law. And we may report on “any matter concerned with” the implementation of environmental law

Enforcement


We investigate suspected serious failures to comply with environmental law by public authorities and enforce compliance where needed.

Government and other public authorities abide by environmental law so it can protect people and protect and improve the environment as intended.

Complaints

- A member of the public may complain to the OEP if they believe that a **public authority** has failed to comply with environmental law.

Receive and assess complaints



Four Main Functions



Enforcement

We investigate suspected serious failures to comply with environmental law by public authorities and enforce compliance where needed.

Government and other public authorities abide by environmental law so it can protect people and protect and improve the environment as intended.

Investigation/ enforcement

- The OEP may investigate if it thinks the complaint indicates there may have been a failure to comply with environmental law and that it would be a **serious failure**.
- The public body's internal complaints procedure must be exhausted first.
- The OEP will not only be an enforcer. In many cases we anticipate it will be possible and appropriate to resolve an issue without recourse to formal enforcement procedures.

Investigations: DAERA advice on ammonia emissions / regulation of combined sewer overflows in England

Prioritisation of activities

Our prioritisation approach is founded on four principles:

We will prioritise by outcome and across our functions so that **our work makes the most difference**

We will **prioritise by judgement, supported by the evidence** available at the time

Our judgements on what we prioritise, and when, will be guided by four main questions:

- how large an effect could our action have?
- how likely is our ability to have that effect?
- what is the strategic fit?
- what is our capacity and capability to deliver?

We will be **transparent about the matters we prioritise**.

Our **Board and senior leaders will make our judgements on prioritisation**. These will be set out in our corporate plan at the start of each business year.


